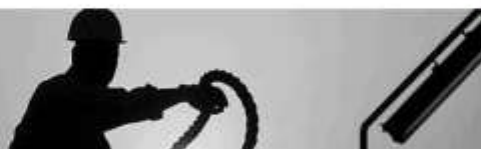
QUALITY POLICY
